On December 13, 2021, the Board of Trustees of Jemez Mountains Electric Cooperative, Inc., (JMEC) issued a press release announcing Board approval to retain a forensic auditing firm to conduct a forensic audit of the cooperative to make certain JMEC is performing to the expected best practices.

This audit will examine specific financial practices of the organization and, as with any audit, return with findings and recommendations for action. The JMEC Board of Trustees must work with the selected auditor to define its final scope and propose a reasonable timeframe for its completion.

Although the JMEC leadership has submitted issues for the audit, the Board of Trustees is also inviting any JMEC member to submit subject matter for consideration of inclusion in the forensic audit.
